

## Safety and Compliance Information for Blink Floodlight Mount

### **BATTERY SAFETY**

This product contains alkaline batteries. This device requires batteries for use. Only use new 1.5V alkaline or 1.2 NiMH rechargeable D-sized batteries. Never mix old and new batteries. Keep all of the batteries out of the reach of children. Do not open, disassemble, puncture, cut, bend, shred or heat the batteries and do not allow metal objects to touch the battery terminals on the remote as they can become hot and cause burns. Remove all batteries if they are worn out or before storing your Device for an extended period of time. Dispose of all batteries in accordance with applicable laws and regulations and do not dispose of batteries by throwing them into a fire. If any batteries begin to leak, take steps to prevent the fluid from coming into direct contact with skin or clothes as the fluid could be corrosive and may be toxic. After cleaning, wait for the device to dry completely before restoring power.

Use only accessories supplied with your device, or specifically marketed for use with your device, to power your device. Use of third-party accessories may impact your device's performance. In limited circumstances, use of third-party accessories may void your device's limited warranty.
